RAUNER APPOINTS SPRINGFIELD ATTORNEY to head GAMING BOARD

Judge Aaron Jaffe will not be re-appointed to head Illinois' Gaming Board. Instead, Governor Rauner is looking to Springfield corporate attorney Don Tracy to fill those shoes.

Casino revenue declines; some call gambling market saturated

While debate over the rejection of Kenosha's Hard Rock Hotel & Casino project continues, gambling industry insiders are mulling the overall business climate for the gaming industry.

In Atlantic City, four out of 10 casinos, including the Trump Plaza Hotel and Casino, closed in 2014.

In Illinois, casino revenues have fallen 44 percent since 2007, said Tom Swoik, executive director of the Illinois Casino Gaming Association. Swoik said his association is fighting any expansion of gambling in Illinois, believing there is no room in the market. Read more
