# Medical Marijuana - Unintended Consequences



#### Man held for pot crimes gave cannabis oil to ill grandpa

A St. Charles-area man arrested last week for operating a large, sophisticated marijuanagrowing business inside his home had run afoul of his family for supplying his elderly, dying grandfather with cannabis oil, according to court files.

Kane sheriff's deputies raided David Robbins' house and confiscated 13 pounds of processed marijuana, along with 460 marijuana plants and an extensive irrigation and ventilation system.

That protective order was filed against Robbins by his father this summer in DuPage County, on behalf of **92-year-old Joseph Robbins**.

J. Michael Robbins, 65, of Downers Grove, went to court after bringing his elderly father to the hospital in July. Joseph, according to the order, was suffering from extremely high blood pressure and was "very limp and almost unconscious," according to the court file.

The hospital found cannabis in his system, and Michael Robbins said he found out his son, David, was giving the grandfather cannabis oil four times a day in an attempt to treat the elderly man's prostate cancer. Read more
