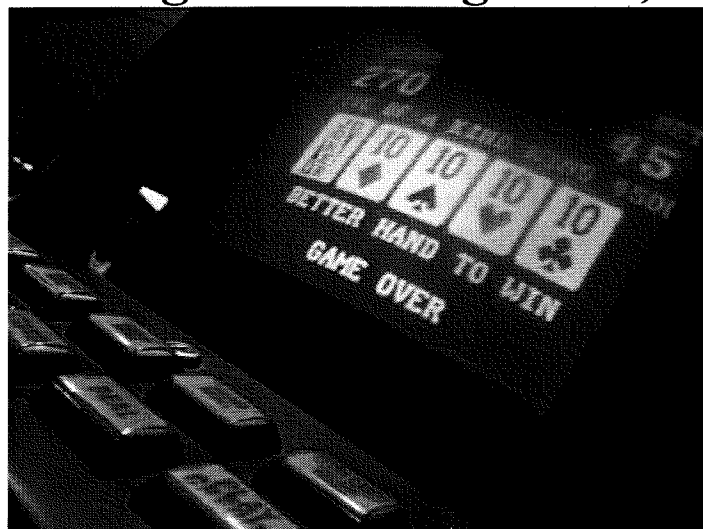

## Gambling Alert - August 23, 2018



### Legislative hearing on gambling expansion

. . . Three residents testified that expanded gaming would lead to increased gambling addiction, thefts and marital problems - especially among minorities, senior citizens and people with lower incomes.

"Video gaming is more addictive than other kinds of gaming," Jeannie Evans, of Chicago, said. "This brings in local people. This is not money from out of state ... Raising revenue off the backs of the poor and vulnerable is not the way to raise money."

Lawmakers heard CGFA testimony (that despite a projected \$1 billion in additional annual gross revenue from five new casinos and thousands of addition video gaming terminals, expanded gaming might net the state just \$12 million a year in additional tax revenue. The hearing at noon will mainly focus on legalizing Internet gambling, Sports gambling, and Internet fantasy sports gambling.

### Why Chicago's Hedging on a City-Owned Casino

The Chicago casino would be owned by the city, and they are now saying "it may not be financially feasible" for Chicago, or a casino operator hired by the city, to pay an up-front cost of roughly \$120 million (a \$30,000 fee for each of the city's allotted 4,000 gaming positions), city lobbyist Victoria Watkins told lawmakers. SB 7 would expand video gambling to allow establishments to have 6 machines, double the maximum bet to \$4, increase jackpots, and allow unlimited progressive jackpots.
